



CCPPD Scholarship

\$2,000 SCHOLARSHIP WILL BE AWARDED

Eligibility: This scholarship is limited to any student/applicant, enrolled in a utility line program through any accredited college, university, trade school, or community college who meets the following criteria:

- (1) Home/residence must be served by Cuming County Public Power District (CCPPD).
- (2) Applicant cannot be a previous winner of a CCPPD Scholarship.
- (3) Applicant has earned a High School Diploma or GED Completion Certificate.
- (4) Applicant must be registered at and/or attending an accredited college or trade school.
- (5) CCPPD employees are not eligible.

Application Submission Requirements:

The applicant must complete all areas of the application. (the application can also be filled out online at ccppd.com/utility-line-scholarship)

CHECKLIST: On a separate sheet of paper list:

- List your school activities
- Your educational goals and plans for the future.
- Statement of your work experience.
- Leadership and/or community service.

Qualifications: The scholarship will be awarded based on Leadership and/or Community Service and Educational Goals and Career Plans.

Notification: The scholarship winner will be notified following the March 15th deadline.

Selection: 1- \$2,000 scholarship is available. CCPPD board members make the final decision.

Application Deadline: Applications must be received by March 15th.

Disbursement: The scholarship recipient must provide Cuming County Public Power District with a copy of his/her college registration documentation (i.e. acceptance letter and class schedule from the college, university, trade school, or community college). The \$2,000 Scholarship is dispersed as follows: \$500 after the first year and \$1,500 upon completion of the program.

Deadline: Registration documentation must be received no later than March 15th to receive the scholarship. If the scholarship recipient fails to submit the required documentation, the scholarship will not be awarded.
